### 2. How to count:

- Number of votes a shareholder has corresponds to number of shares he owns (01 share 01 voting right).
- Postal ballot form shall be deemed invalid and your vote may not be counted if:
  - No signature of individual shareholder or signature of legal person and seal of the organisation in the postal ballot form;
  - Mark in 02 boxes or more for all items:
  - Postal ballot form received after deadline:
  - Postal vote statement is modified, erased, or marked with sysbols.
- Mark in 02 boxes or more for 01 item will be considered as it is invalid/will not be counted;
- Votes in favor (approval): Shareholders mark (x) of  $(\sqrt{1})$  in "Approval" box, that vote will be considered as approved.
- Votes against (disapproval): Shareholders mark (x) of  $(\sqrt{)}$  in "disapproval" box, that vote will be considered as disapproved.
- Votes abstention: (i) Shareholders mark (x) of  $(\sqrt{})$  in "Abstention" box; or (ii) no box was marked, that vote will be considered as "Abstention".
