

- Pursuant to the Law No 70/2006/QH11 2006 passed by the National Assembly on 29 June 2006 on Securities; the Law No 62/2010/QH12 passed by the National Assembly on 24 November 2010 on amending and supplementing a number of articles of Law No 70/2006/QH11 on Securities;
- Pursuant to the Charter of Transport and Industry Development Investment Joint Stock Company (TRACODI) approved by shareholders on 16 August 2017 (which was amended and supplemented at its 5th session);

- 1. Supervisory Board and its members have rights and obligations prescribed in Article 165 of the Law on Enterprise and this Charter, main rights and responsibilities as follows: .
 - j. Supervisors have right to attend meetings of the Board of Directors and to discuss issues but not to vote.
 - k. To exercise other rights and obligations prescribed in this Charter and under Article 165, Article 166, Article 167, Article 168 and other provisions of the Law on Enterprise.
