- Pursuant to the Securities Law No.54/2019/QH14 dated November 26th, 2019 of the National Assembly of the Socialist Republic of Vietnam;
- Pursuant to Circular No.96/2020/TT-BTC dated November 11th, 2020 of the Ministry of Finance guiding information disclosure on the securities market;
- Pursuant to Circular No.116/2020/TT-BTC dated December 31st, 2020 of the Ministry of Finance guiding a number of articles of corporate governance applied to the public company;
- Pursuant to the Charter of Tracodi approved by the Board of Directors on April 27th, 2022 as authorized by the General Meeting of Shareholders on November 2021 (the 20th amendment);
- Pursuant to Resolution No.48/2022/NQ-HDQT-TCD dated June 24th, 2022 of the Board of Directors of TCD to execute to collect the shareholders' opinion through postal ballot in July 2022;

The Board of Directors (BODs) of Transport and Industry Development Investment Joint Stock Company (TRACODI) shall submit to the General Meeting of Shareholders for consideration the amendment and supplementation of TRACODI's charter approved for the 20th time on April 27th, 2022 with the following contents:
