## ELECTRONIC MEETING SYSTEM USER MANUAL

To attend the e-AGM please follow these steps:

## Step 1: Log in

Access the tcd.bvote.vn page  $\rightarrow$  Click the button "Shareholders Login" (using computer/tablet or smartphone with internet connection, wifi/3G, etc.)



### Step 2: Confirm attendance

Please click "I confirm to attend the meeting" to access the electronic meeting.

#### Step 3: Vote to start the meeting

• Then click "Submit" for each item or click "Submit all" for the selected items.

#### **Step 4: Election**

Shareholder can split his votes equally to all candidates by ticking on the box or enter the number of votes for each respective candidate, then click "Submit".

To make it easy, if you enter the percentage of votes, the system will also show the corresponding number of votes for each candidate. The percentage will present total number of votes shareholders have. The winner will have highest rate in which the rate will be calculated as number of votes for candite dividing all of votes cast.

The number of votes is rounded off a decimal number to the nearest whole number. The votes have not dedicated for any candidate (shareholders has not vote/ decimal number of votes/...) will be considered not to vote for any candidate.
