

RESOLUTION

GENERAL MEETING OF SHAREHOLDERS IN JANUARY 2018 TRANSPORT AND INDUSTRY DEVELOPMENT INVESTMENT JOINT STOCK COMPANY

(The vote through postal ballot)

- Pursuant to the Law No 68/2014/QH13 passed by the National Assembly of the Socialist Republic of Vietnam on Enterprise on 26 November 2014;
- Pursuant to the Law No 70/2006/QH11 2006 passed by the National Assembly on 29 June 2006 on Securities; the Law No 62/2010/QH12 passed by the National Assembly on 24 November 2010 on amending and supplementing a number of articles of Law No 70/2006/QH11 on Securities;
- Pursuant to the Charter of Transport and Industry Development Investment Joint Stock Company (TRACODI) approved by shareholders on 16 August 2017 (which was amended and supplemented at its 5th session);
- Pursuant to the Proposals submitted by BOD on the vote through postal ballot;
- Pursuant to the Minutes of vote counting No 01/2018/BB-ĐHĐCĐ-TCD on 31 January 2018;

DECIDES

- Article 1. To approve supplementing following branches to business lines of Transport and Industry Development Investment Joint Stock Company (TRACODI) (details in Proposal No 01/2018/TT-HĐQT-TCD on 16 January 2018), specially:
 - 1. Architectural practice and related technical consultancy
 - 2. Leasing of motor vehicles
 - Installing power (transmission) systems

- Article 2. To pass amending and suppementing a number of articles in the Charter of Transport and Industry Development Investment Joint Stock Company (TRACODI) (details in Proposal No 02/2018/TT-HĐQT-TCD on 16 January 2018), namely:
 - 2.1 To amend Clause 4 of Article 2:
 - 4. The Chief Executive Officer is the Legal Representative of the Company.
 - 2.2 To amend Clause 1 of Article 3: numbering the points will be changed from letters (alphabet character) to numbers.
 - 2.3 To supplement following points in Clause 1 of Article 3:
 - 38. Architectural practice and related technical consultancy
 - 39. Leasing of motor vehicles
 - 40. Installing power (transmission) systems

- 2.4 To supplement points in Clause 3 of Article 10 as follows:
 - "3. A shareholder or a group of shareholders holding ten (10)% or more ordinary shares for a consecutive period of six (06) months or more will have additional rights as follows:

...

- e. To examine and extract the minutes and resolutions of BOD, semiannual and annual financial statements in accordance with Vietnamese accounting forms and other reports of Supervisory Board.
- f. Other rights provided in this Charter and the laws.".
- 2.5 To supplement points to Item A of Clause 6 of Article 23 as follows:
 - "6. The invitation for meeting of BOD must be sent to board members, members of Supervisory Board at least (03) three days prior to the date on which the meeting to be held, board members may refuse the invitation in writing and such refusal shall have retroactive effect".
- 2.6 To supplement points in Clause 1 of Article 28 as follows:
 - "1. Supervisory Board and its members have rights and obligations punder Article 165 of the Law on Enterprise and this Charter, main rights and obligations as follows:

- j. Supervisors have right to attend meetings of the Board of Directors and to discuss issues but not to vote.
- k. To exercise other rights and obligations prescribed in this Charter and Article 165, Article 166, Article 167, Article 168 and other provisions of the Law on Enterprise.
- 2.7 To supplement points in Clause 4 of Article 28 as follows:
 - "4. ... Supervisors shall elect (01) one of them to be the head of the Supervisory Board on the majority principle. The head of Supervisory Board must be a professional accountant and work on full-time basis in the Company. The rights and obligations of the head of Supervisory Board as follows: ...".

Votes in favor reached 71.95% of total voting rights of the Company.

Article 3. This Resolution has been approved by the General Assembly of Shareholders by the vote through postal ballot in January 2018, it takes effect on the date the Resolution signed and enclosed with the minutes of vote counting.

Article 4. To assign BOD of TRACODI to execute this Resolution. BOD is responsible for reporting the results of the implementation of this Resolution in next Annual General Meeting of Shareholders.
